These Magnetel® Gauges are available in four basic models:

- Model 6336 Incorporates 4" [100 mm] dial and is designed for top mounting.
- Model 6360 Incorporates 8" [200 mm] dial and is desinged for top mounting.
- Model 6339 Incorporates 4" [100 mm] dial and is desinged for side, end or angle mounting.
- Model 6342 Incorporates 8" [200 mm] dial and is designed for side, end or angle mounitng.

The large, easy-to-read dials are also easy to remove and replace. Materials of construction vary depneding on the types of liquids to be gauged. Many different optional features are available to meet your specific needs. These materials and options, along with their picing impact. Are summarized for each model in price list 6300.

Magnetel® gauges are desinged for working pressures ranging from atmospheric to 450 [31 Bar] psig.

When ordering, specify:

- **1.** Liquid to be gauged specific gravity.
- **2.** Inside diameter of tank, head style; ellipsoidal, semi-ellipsoidal or hemispherical.
- **3.** Complete model number desired from price list 6300, (example, M6342-11).
- 4. Prefix letters for available options from price list 6300.
- **5.** If a dial other than standard is required, furnish drawing and/or details.
- **6.** Furnish tank drawings whenever ordering gauges for angle-mounting or for installation in vertical tanks.
- 7. Tank mounting flange, if required (see chart above).

CAUTION: For LP Gas or NH3 applications requiring 2" NPT connection, specify Y6300 Series Magnetel® gauges which includes 0022-00525 schedule 80 adapter assembled to gauge.

NOTE: Y6300 Series gauges will fit through 2" pipe coupling but will NOT fit through 2" pipe nipple.
